The Alternative Entrée Meal Plan is available to all inmates free of charge. You are required to sign up in advance if you would like to participate in the Alternative Entrée Meal Plan. **This is the OFFICAL SIGN-UP FORM to PARTICIPATE.** If you choose to participate in the Alternative Entrée Program and are observed or caught trying to pick-up a regular tray you can receive disciplinary action and/or be removed from the program. Once you sign-up for the Alternative Entrée Program we expect you to follow the instructions given by your institution. If you decide that you no longer want to participate in the Alternative Entrée Meal Plan you will need to submit a request in writing.

Written request would have to be submitted to your facility's designee and approved to participate in this plan. Written request must include reasons why the regular vegan menu option is not adequate for your beliefs.
